### **Organizing Authority**

Nyländska Jaktklubben (NJK) in association with the X-41 class organization.

### **NOTICE OF RACE**

#### **1 RULES**

The regatta will be governed by the rules as defined in the *Racing Rules of Sailing 2009-2012* (RRS). The Class X-41 Rules with the following clarifications/amendments:

- 1) All yachts shall have antifouling paint applied over the entire underwater section of hull and hull appendages, this antifouling may be lightly sanded but shall not be removed.
- 2) Mast jack shall not be onboard while racing.
- ~~3) Genoa and combi halyards as per rule C.10.9.c.1 may have a 10mm. minimum diameter.~~
- 3) At any time during the event, the weight of the crew dressed in swimwear shall not exceed 850 kg.

Offshore Special Regulation (OSR) category 4.

ISAF Sailor Classification, regulation 22.

The English text will prevail.

#### **2 ADVERTISING**

Advertising is free as per ISAF Regulation 20.

The OA has the right to place sponsor advertisements on the bow of participating yachts.

#### **3 ELIGIBILITY AND ENTRIES**

The regatta is open to all yachts of the X-41 Class. Eligible boats may enter by completing the attached form or on-line on the website [www.x-yachts.com](http://www.x-yachts.com) and sending it to [robi@x-yachts.fi](mailto:robi@x-yachts.fi) before on **June 16<sup>th</sup> of 2012**.

Late entries, i.e. entries that arrive after the date indicated above, will be accepted by the OC if otherwise complete.

Entries, which arrive without the entry fee, are not accepted.

#### **4 CREW LIST**

*Crew lists, with the names of crew members and –optional substitutes shall be filled-in no later than July 15<sup>th</sup> of 2012 and sent to the OC [robi@x-yachts.fi](mailto:robi@x-yachts.fi). The crew lists shall contain the ISAF Sailor Classification Code and the nationality of each crew member and the name(s) of the helmsman. Regarding ISAF Regulation 22 (22.4.1) the deadline is Friday, August 10<sup>th</sup> of 2012 at 12:00. Crew lists will be posted on the Official Notice Board no later than Saturday, August 11<sup>th</sup> of 2012 at 09:00. Classification protests time-limit is Saturday, August 11<sup>th</sup> of 2012 at 16:00.*

## 7 MEASUREMENTS

Each boat shall produce a valid measurement certificate, to be handed to the Race Office at the registration. The RC holds the right to conduct inspections, at its discretion, on board boats before and after each race.

## 8 SAILING INSTRUCTIONS

Sailing Instructions will be available to competitors from 09:00 at the Race Office at NJK Blekholmen on August 10<sup>th</sup> of 2012.

## 9 VENUE

The regatta venue is at the NJK club harbor on the island of Blekholmen (fi: Valkosaari).

The race office is located in the NJK clubhouse on the island of Blekholmen.

## 10 SCORING

The Low Point scoring system of Appendix A will apply. Should less than four races be completed, the scoring of the series of races of a yacht will be the total of its scorings. From 4 to 8 races, 1 discard. After 9 races, 2 discards. 10 races are scheduled, 4 of which shall be completed, to constitute the valid series for the assignment of the title.

## 11 BERTHING

Berthing in the NJK club harbor of Blekholmen is included in the entry fee and is available between August 10 and August 16 of 2012 free of charge.

## 12 PRIZES

Prizes will be awarded to the first five boats best classified

## 13 COURSES

Courses will be on the waters south of Helsinki. The course type will be a windward-leeward course as prescribed in the X-41 championship guidelines.

## 14 SOCIAL EVENTS

Competitors will be informed about social events by a notice posted on the official notice board.

## 15 DISCLAIMER OF LIABILITY

Competitors participate in the regatta entirely at their own risk. See rule 4, Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

## 16 INSURANCE

**Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of EUR 1 000 000.00 or equivalent.**

## 17 TRAVELLING and ACCOMMODATION

Information on travelling, transportation and accommodation will be published on the championship's internet pages as soon as it is available.
